# PASSED LEGISLATION from the 89th Legislative Session



The 2025 89th Legislative Session brought significant legislative victories aligned with Educate Texas' priorities. Explore the passed legislation within our priority areas, along with additional education-related measures, below.

#### College and Career Readiness



HB 2, ARTICLE VI + HB 120: Career + Technical Education Significantly boosts P-TECH funding from \$50 to \$150 per student. Establishes stronger, more defined standards for demonstrating College and Career Readiness among educationally disadvantaged students. Reinforces that dual credit courses remain free of charge for P-TECH and R-PEP students. Expands Career and Technical Education (CTE) pathways by including JROTC course offerings. Passed in both HB 2 & HB 120.



HB 322: JET Program Expansion Expands allowable use of JET funds for technology purposes including acquisition, implementation and maintenance of CTE electronics.



SB 2314: My
Texas Future portal

Codifies the THECB's My Texas Future portal to facilitate awareness towards postsecondary opportunity.

## Degree & Credential Attainment



SB 1786: Community
College Finance

Expands HB 8 (88R) to further reflect community college needs:

- FAST: Expands free dual credit to students who qualify for free or reduced-price lunch in the previous four years.
- Transfer Outcomes: Awarding community colleges for successful transfer to private or independent colleges.
- Credential of Value (CoV) Methodology: Refines definition of CoV to allow flexibility of in-demand fields and jobs.



SB 2231: Free College
Application Week

Establishes the 2<sup>nd</sup> full week of October as "Free College Application Week". Individuals across the state may apply any institution of higher education for undergraduate admission feefree.



SB 3039: Transfer Student Accessibility

Improves transparency in credit transfers between Texas public colleges and universities by requiring reporting of denied credits, publication of program requirements, and stronger transfer student support.

HB 2: School Finance & Teacher Workforce Support Omnibus public school finance bill to enhance education operations

- o Article I: Increases Teacher Compensation
- Article II: Establishes PREP Allotment for teacher preparation pathways
- Article III: Teacher bill of rights to expand job satisfaction
- Article IV: Special education supports
- Article V: Early Literacy and Numeracy

#### Other Notable Legislation



SB 2- Education Savings
Account

Establishes a statewide program for Education Savings Account (ESA).



HB 20: Applied Sciences
Pathway Program

Creates the Applied Sciences Pathway Program, enabling high school juniors and seniors to earn both a diploma and a Level I or II certificate in high-demand trades like welding, HVAC, and IT through partnerships with higher education institutions.



SB 37: Governance of Public
Higher Education
Institutions

Enhances power of University System regents to directs additional oversight on curricula, degrees and governance.



SB 530: Higher Education
Accreditation

Expands eligibility for higher education accreditation to include any recognized accrediting agency.



SB 1191: GPA Reform

Develops a standardized method for calculating high school grade point averages (GPAs) to include dual credit courses.



HB 2768: IT Apprenticeship Credential Aimed at addressing workforce shortages, the bill creates a state-recognized IT apprenticeship credential at the public junior college and technical institution level.
